

General Criteria

- Applicant must be a member of OTEC and/or...
- Provide proof that the energy efficiency equipment is installed within OTEC's service territory.
- Rebates are subject to funding at the time. Funding is always limited and the programs are operated on a first-come, first-serve basis.
- Rebates will not exceed the cost of the project, including labor and equipment.
- Rebate program requirements must be fully met and verifiable upon completion.
- Additional qualifying criteria may be added or changed depending upon funding sources available.
- Rebates may not be combined

Programs

Commercial Lighting (Commercial)

As long as upgrades demonstrate 25% wattage reduction or more, OTEC can offer attractive rebates for new construction and retrofits. Pre, in-progress and post inspections of lighting projects are required. Rebates vary dependent upon the total calculated energy savings to be achieved, but not more than 70% of the project cost.

Water Heater (Residential & Commercial)

OTEC offers rebates for installation of a new energy efficient electric water heater. Storage, on-demand and heat pump units qualify for an incentive. Contact OTEC for specifications.



Window Replacement (Residential & Commercial)

This program requires pre-qualifications. Please contact OTEC if you have an all electrically heated building with old single pane windows (or double-pane with aluminum framing).

Manufactured Home (Residential Only)

Incentives for new electric Northwest Energy Efficient Manufactured Homes (NEEM). Contact OTEC for documentation required.

Energy Star Electric Appliances (Residential & Commercial)

Incentives for new electric appliances are available. For a current list of rebates offered, call your local OTEC office or visit our website.

Agricultural Program

Many attractive incentives are available to upgrade irrigation systems, sprinklers, cattle fountains, and variable frequency drive (VFD). The rebates vary depending upon the amount of energy savings to be realized.

Thermostats (Residential & Commercial)

Incentives are available for new smart thermostats. Contact OTEC for qualifications prior to purchasing your new thermostat.



Heating, Cooling & Ventilation (HVAC) (Residential & Commercial)

Members can receive a rebate for installation of new HVAC systems. Pre and post verification may be required. Contact OTEC to discuss options.

Custom (Commercial & Residential)

New projects that are going to save energy but are not listed above may have incentives available. Contact your local OTEC office for prerequisites.
